GRANTEE SPOTLIGHT

Blaine County Charitable Fund

A local woman on a single income with a disabled husband approached Mary Fauth, executive director of Blaine County Charitable Fund (BCCF) in Hailey and shared her struggle to cover all household expenses, including vet bills. She'd already cut extra expenses, was sharing a cell phone with her husband and was at risk of not paying that month's rent.

Like so many with unanticipated emergencies, she had to choose between a roof over her head, food insecurity and the health of her beloved dog. This urgent need prompted her to reach out for help, and the community was able to assist by stabilizing her housing and giving her sweet pup some relief.

In 2022, WRWF awarded BCCF \$18,000 for its Emergency Assistance Grant Program, which helps clients maintain stability in times of crisis through financial assistance with rent, first/last deposits, gas and grocery expenses, utility bills and medication costs.

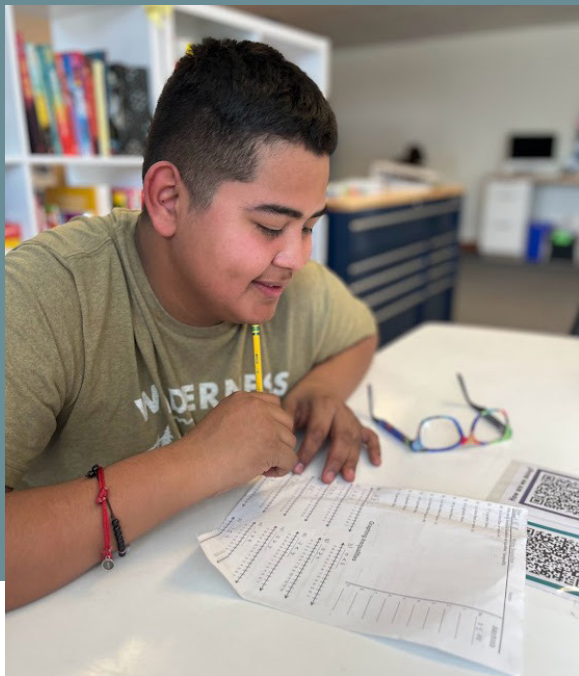
BCCF was founded in 2020 in response to the COVID-19 pandemic that ultimately exposed the community's vast disparity in income. Since then, BCCF has partnered with numerous local organizations and volunteers to make sure hundreds of families stay safe, housed and warm in the winter.

GRANTEE SPOTLIGHT

The Space Idaho



Alex, Wood River Middle School student

On the second floor of the Meriwether building in Hailey, the sound of laughter pours into the hallway from The Space Idaho. Wood River Middle School student Alex, 13, works at a table with friends.

In 2022, The Space Idaho received an \$18,900 WRWF grant to support its Forward Learning Scholars program, which offers high-quality academic after school programs and college counseling to students in grades 6-12.

Alex has participated in many after school programs due to moving schools twice, and says he enjoys The Space most of all. “We do a little bit of math, English and science and afterwards, we do arts and crafts and I play my saxophone,” Alex shared.

“When you come over here, it makes a huge difference. Your negative energy mostly disappears as you walk through the door,” he says. “At The Space, your brain can expand and your heart can expand, too.”

The Space Idaho was founded in 2020 by local educators Naomi Runkel and Kate Ristow, who saw the need to close a significant opportunity gap in education. They offer programs on a sliding scale—meaning that all students can receive after school help.

FOCUS GRANT

Wood River Early Learning Collaborative

In 2022 WRWF awarded the Idaho Association for the Education of Young Children (Idaho AEYC)* funds to establish the Wood River Early Learning Collaborative (WRELC). This first ever Focus Grant, totaling \$200,000 over two years, aims to create an affordable and accessible early childcare and education community for all young children, especially those from underserved families.

Many initial milestones were met in 2022. Kathryn Ivers was hired as Project Director for the WRELC, the Collaborative's Advisory Council and membership were established, and a needs assessment was designed and conducted. The Advisory Council comprises many of the Wood River Valley's most committed, innovative, and influential leaders who are able to tap local resources to support children's early learning and development.

Based on the findings of the 2022 needs assessment, the WRELC has developed a Strategic Action Plan to address these economic, social, and educational needs in 2023 with the second installment of the Focus Grant funds. The plan specifies many concrete steps that can be taken to expand programs and services for young children, their caretakers, their families, and the business community.
